Course Description:

This course will facilitate a critical examination of common ethical issues that may arise in the practice of psychotherapy and assessment. The course will explore boundaries, personal and professional responsibilities in the course of acting ethically, and developing a process to assess situations from an ethical framework. Students will become familiar with the 2002 APA Ethics Code and its applications in various therapeutic settings. Attention will also be paid to specific ethical situations, such as suicidality, informed consent, multiple relationships, and cultural aspects of ethics. Legal issues pertaining to the professional practice of psychotherapy will also be addressed including, but not limited to: confidentiality, privilege, mandated reporting, etc.

Course Objectives:

Upon completion of this course students will:

Ψ Be well versed with the issues covered by the ethics code

- Ψ Apply the ethics code to common situations that may occur within the therapy setting
- Ψ Appreciate the ethical implications of the therapeutic relationship, including special situations such as informed consent, suicide assessment, and ethics in research
- Ψ Develop an ethical decision-making process for approaching ethical problems
- Ψ Understand the implications of ethics with regard to other aspects of the client, such as culture, gender, age, and client type
- Ψ Be knowledgeable about the current legal issues in regard to the professional practice of psychology

Provide assessment, counseling, and consultation services in work with clients by applying psychological and multicultural theories and research to diverse populations, and modifying interventions as needed to work effectively with diverse clients.

Examine personal values and biases, reflect on beliefs, and understand how they impact work with clients and interpersonal relationships with other students and faculty.

Competency 3: Multicultural Knowledge

Papers

Students will complete 5 reflection papers (1-2 pages in length) that will be based on case vignettes that will be provided in class. This will be explained further in our first class session.

Presentation

Each student will select a chapter from the text that they will present in a 10-15 minute oral presentation to the class. In addition, the student will summarize the chapter into a 1-2 page handout that they will provide copies of to their fellow students. This will be explained further in our first class session.

Class Participation & Attendance:

You are expected to attend all classes. Unless special arrangements are made ahead of time with the instructor, your final grade will be negatively impacted by any absences. You will earn points for attending and participating in a meaningful way during the thirteen class meetings. You will begin with 25 points but will forfeit 5 points for each missed class or classes in which you do not participate actively in. School policy dictates minimal attendance required to earn credit for any class. If you miss more than 8 hours of instruction for any reason, you will need to withdraw from the class or receive a grade of F.

Final Exam:

The exam may include multiple choice questions, brief essay questions, and vignettes.

Criteria for Class Participation

Grade	
A = 90+	Student actively participated in discussions in >80% of class sessions; nearly all comments were thought provoking and incorporated material from the assigned readings
B = 80 – 89	Student actively participated in discussions in >80% of class sessions; most of the comments were thought provoking and incorporated material from the assigned readings
C = 70 – 79	Student participated in discussions in >70% of class sessions; comments/questions demonstrate a surface level understanding of course topics

Criteria for Paper

Grade	
A = 90+	Paper is in appropriate APA format, well thought out, and provides excellent coverage of material
B = 80 – 89	Paper is well thought out, but is missing one component of APA format OR coverage of material is adequate
C = 70 – 79	Insufficient number of references provided AND limited coverage
F = <70	Paper is disorganized AND coverage is not adequate AND does not conform to APA format, or there is evidence of plagiarism , or paper not submitted

All resources in Argosy University’s online collection are available through the Internet. The campus librarian will provide students with links, user IDs, and passwords.

Library Resources: Argosy University’s core online collection features nearly 21,000 full-text journals and 23,000 electronic books and other content covering all academic subject areas including Business & Economics, Career & General Education, Computers, Engineering & Applied Science, Humanities, Science, Medicine & Allied Health, and Social & Behavior Sciences. Students are encouraged to seek research and reference assistance from campus librarians.

Information Literacy: Argosy University’s Information Literacy Tutorial was developed to teach students fundamental and transferable research skills. The tutorial consists of five modules where students learn to select sources appropriate for academic-level research, search periodical indexes and search engines, and evaluate and cite information. In the tutorial, students study concepts and practice them through interactions. At the conclusion of each module, they can test their comprehension and receive immediate feedback. Turnitin compares submitted papers to billions of pages of content and provides a comparison report to your instructor. This comparison detects papers that share common information and duplicative language.
